2. The Teacher agrees with the said Board of Public School Trustees to teach and conduct the said school during the said term, according to the said Law and Regulations in that behalf.
3. The foregoing is subject to the following conditions: (1) That the Teacher shall continue to be the holder of a legal certificate of qualification as a Public School Teacher in Ontario. (2) That holidays and vacations prescribed by the Laws and Regulations are excepted from the said term. (3) That the days on which the Teacher has attended the meetings of the Teachers' Associations or Institutes, as certified by the Inspector or Chairman thereof, shall be allowed has ifhad actually taught in the said School; and (4), That in case of sickness, as certified by a registered medical practitioner shall be entitled to receive h salary without deduction, for such period as may be authorized under the Statute in that behalf.
4. The Board of Public School Trustees and the Teacher may, at their option, respectively, terminate this engagement by giving notice in writing to the other of them at least
5. This agreement shall also be construed to continue in force from year to year, unless and until it is terminated by the notice hereinbefore prescribed.
