CREIGHTON MINE ATHLETIC ASSOCIATION CONSTITUTION

I - NAME

The Association shall be known as the CREIGHTON MINE ATHLETIC ASSOCIATION.

II - OBJECT

(a) The object of this Association shall be to organize, sponsor and control athletic activities in the area of Creighton Mine.

(b) The administration of all funds of the Association.

III - MEMBERSHIP

(a) All employees of INCO and all non-employees resident in Sudbury Area and Creighton Area shall be eligible for membership in this association.

(b) Any exception to part (a) must be approved by the Executive.

(c) Any member may be suspended or expelled by a majority vote of the membership at a General Meeting.

An expelled member shall have the right to refer his case to a General Membership Meeting of the Association called at his request.

IV - ORGANIZATION & OFFICERS

(a) Complete control of this Association is vested in the Executive Committee other than suspending or expelling any member.

(b) The Executive Committee shall consist of a Permanent President (Superintendent Of Creighton Mine), Chairman, Secretary-Treasurer and members representing major activities: BASEBALL (Sr.), BASEBALL (Jr.), SOFTBALL, HOCKEY, TENNIS, BASKETBALL, SOCCER, ADVERTISING, MEMBERSHIP and any others deemed necessary.

(c) The Executive Committee shall have the power, if necessary, to appoint Sub-Committees which may include members of the organization other than members of the Executive Committee. Such Sub-Committee shall be directly responsible to the Representative of such Committee and must be from members of the C.M.A.A..

V - ELECTION OF OFFICERS

(a) The Annual Meeting and Election Of Officers shall take place not later than March 1st. of each year.

(b) Nominations for Executive Officers shall take place at the Annual Meeting. Only members of the Association shall be allowed to hold office and vote at this meeting. If a member cannot attend but is willing to accept an Executive Office or Offices, if nominated, such member shall signify his intention in writing to a member of the Association for presentation at the time specified for opening the Annual Meeting.

The date, place and time of the Annual Meeting shall be posted on Notice Boards at Creighton Mine and in the Town Of CREIGHTON at least one week in advance of the Annual Meeting.

These men shall have votive powers following the Annual Meeting but will not assume office until sitting chairmen have concluded activities in progress.

These new officers shall remain in office for such time after the next Annual Meeting as is required to complete their seasonal activities.

(d) An honorarium of \$15.00 monthly shall be allowed the Secretary-Treasurer.
